

"CORRUGAL" SOLID CORRUGATED ANTIFOG POLYCARBONATE SHEET 15 YEAR LIMITED WARRANTY

POLYGAL, INC. (hereinafter "Polygal Inc") warrants that for a period of 15 years from the date of original purchase, **"Corrugal" Solid Corrugated antifog treated Polycarbonate Sheets** (hereinafter: "the product") will not undergo a loss in light transmission in excess of 6 percent in comparison with the original value when tested in accordance with ASTM-D-1003-07; and/or will not undergo a change in yellowness index in excess of 10 delta, or 15 delta in case of white opal or diffuser product, in comparison with the original value when tested in accordance with ASTM D 1925-93, ISO 17223 - 2014 and/or will not lose its impact strength in the event of hail alone, as described below.

Loss of "Impact strength in the event of hail" shall be determined by an impact test according to ASTM-D-5628-95 geometry FE (tup diameter 20mm). In this test, failure is determined when the sheet is penetrated by the tup. The sheet does not reach the required standard if the Mean Failure Energy obtained in the test is less than 0.831 Joule. This energy is equal to the energy generated by a 20 mm diameter ice ball at a speed of 21 m/s.

If Polygal Inc, at its sole discretion, concludes that the product does not perform as stated during the warranty period, Polygal Inc shall, at its sole discretion, shall either supply replacement sheets or refund the purchase price thereof according to the following table:

Time from Original Purchase Date	Material Replacement or Refund
First 10 years	100%
11 th year	75%
12 th year	60%
13 th year	45%
14 th year	30%
15 th year	15%

In any event, Polygal Inc shall have no liability whatsoever for the cost of removal of defective sheets or the installation of replacement sheets, or be liable for consequential or other loss, damage, misuse, improper storage, neglect or misapplication of the product, or other costs other than those specifically expressed herein.

Conditions:

- This warranty applies only to the product which has been treated, installed, cleaned and maintained according to manufacturer's recommendations.
- It is important to note that the product is protected on one side with a special UV radiation protective layer. This protected side must be installed on the exterior side of the installation for this warranty to be in effect.
- No warranties are extended to the abrasion resistance characteristics of the product. No warranties are extended to the yellowing or loss of light transmission caused by dirt, scratches, breakage, backward radiation or other damage.
- This warranty specifically excludes sheets that have been formed or molded by vacuum or heat methods.

For the warranty to apply, every warranty claim must be notified in writing to Polygal Inc or its accredited agent within the warranty period and immediately after the occurrence of the defect, enclosing the sales receipt. The claimant must certify that the above conditions have been fulfilled and must allow inspection at the installation site.
